GFWC PHOTOGRAPHY CONTEST - 2020-2022

There have been changes made to the GFWC Photography Contest. To begin, there are now only two contests. The first is The World In Pictures Contest with photos of people, places, and things at home and around the world that impact our lives in a meaningful way expressed in one of three categories:

Our World Up Close - Creation of a visual that offers a novel or a macro image that takes the viewer into a whole new, tiny world.

Natural Wonders - Photos of mountains, meadows, sand hills, rivers, oceans, waterfalls, deserts, or any other magnificent vista using wide angles and panoramas

Reflections - Features a setting, situation, or landmark that brings back moving memories, or capture a fleeting image reflected in glass, water, or another mirrored surface.

The second Photography Contest is GFWC *Living the Volunteer Spirit Contest.* These photographs should capture the special moments in the lives of GFWC clubwomen as they meet, plan, advocate, volunteer, in groups or one-on-one.

Photos must be a member's original work and must be taken between January1, 2019 and December31, 2020, providing a special allowance for two years of photographs for the 2021 contests, since the 2020 GFWC National Contests were not held. Photographs must be taken between January 2021 and December31, 2021, for the 2022 Photography Contests.

ADDITIONS TO OUR BY-LAWS

It has been strongly suggested by the GFWC Administration that clubs take immediate steps to put electronic meetings and electronic voting into their by-laws.

It has been recommended by the Executive Board to add the following to our by-laws:

The following would be added to Article XI. (Elections) making it Section 4:

In the case of a national emergency, state emergency, or any type of event (manmade or natural) that could potentially put members in danger, the President, with the consent of the majority of the Executive Committee, may order that elections be held by mail or electronically.

The following would be added to Article IX, (Meetings) making it Section 7:

In the case of a national emergency, state emergency, or any type of event (manmade or natural) that could potentially put members in danger, the President, with the consent of the majority of the Executive Committee, may order that an electronic meeting be held as a substitute for a regular, executive committee, or special meeting.

Voting will be held at the Oct. 1st, 2020 general meeting.
